Candidates who have passed out M.B.B.S. examination from any of the University outside West Bengal shall have to submit Resident/Domicile Certificate in the prescribed **Form "B"** duly issued by the authorities of the respective localities at the time of nomination where their parents reside duly attested by 1st Class Magistrate.
